4. First-Aid Measures

Description of first aid measures

First aid personnel should pay attention to their own safety. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). 6. Accidental Release Measures

7. Handling and Storage

Precautions for safe handling

Avoid all sources of ignition: heat, sparks, open flame. Product may charge electrostatically: always use earthing leads when transferring from one container to another and earth containers. It is recommended that operators should wear antistatic clothing and footwear. Solvent vapours are heavier than air and spread along floors. Vapour forms explosive mixtures with air. The relevant fire protection measures should be noted. Use explosion-proof equipment.

11. Toxicological Information

Information on toxicological effects

Assessment of acute toxicity:

Exposure to component solvent vapour concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effect on kidney, liver and central nervous system.
